

## LIMITED LIFETIME WARRANTY

Two Brothers Racing, Inc. warrants that the product listed on the attached registration card is free from manufacturer defects in material and workmanship for life of the original owner on the original vehicle in which the product was installed. The warranty is good only to the original purchaser in which the warranty registration is on file. Each product must be registered with Two Brothers Racing in order to activate the lifetime warranty. Warranty can be activated with the warranty registration card. It is the customer responsibility to verify warranty registration.

This limited warranty does not cover any damage to the product listed on the attached registration card that results from improper installation, accident, abuse, misuse, natural disaster, insufficient or excessive electrical supply, abnormal mechanical or environmental conditions, or any unauthorized disassembly, repair, or modification. This limited warranty also does not apply if the original identification information has been altered, obliterated or removed, has not been handled or packaged correctly, has been sold as second-hand or has been resold.

This limited warranty covers only repair and or replacement for defective products listed on the attached registration card, as provided above. Two Brothers Racing is not liable for, and does not cover under warranty, any labor for removing or re-installing defective products.

### WARRANTY COVERAGE:

- This warranty is provided to the original purchaser of the product listed on the attached registration card from an authorized Two Brothers Racing re-seller or Two Brothers Racing direct.
- Warranty is non-transferable; no returns will be accepted from third parties or without warranty registration confirmation.
- No returns will be accepted without a valid Return Authorization # (RA#) printed on the outside on the package and a copy of the original receipt, or warranty registration verification included inside the package. The RA# must be obtained from Two Brothers Racing, Inc (TBR) prior to shipping the product to TBR.
- Any packages sent without an RA # printed on the outside of the package will be refused and returned to sender.
- Product returned without a valid RA # will be refused.
- Product returned without proof of purchase, or warranty registration will be processed as a repair. Sender will be responsible for the retail costs of all parts and in addition, to a repair rate of \$100.00 per hr, min charge of 1 hour.
- All returns must be sent with a Valid RA#, by the Registered user only, to Two Brothers Racing, Inc. 401 S. Grand Ave. Santa Ana, Ca 92705; Attn: Returns. 1-800-211-2767.

**LIABILITY:** The acceptance and/or use of any merchandise purchased from Two Brothers Racing by the customer hereby shall release Two Brothers Racing from any and all liability pertaining to the use of such merchandise. The customer recognizes that any alteration or modification to any vehicle may increase the risk of injury, accident or death, and may also render the vehicle illegal for use.

**EXTENT OF WARRANTY:** All warranty claims properly returned to Two Brothers Racing will be repaired or replaced by Two Brothers Racing. Two Brothers Racing is not responsible for any other expense incurred by the customer under the terms of this lifetime warranty, nor is Two Brothers Racing responsible for any damages either consequential, incidental, special, contingent, or otherwise, or expenses or injury arising directly or indirectly from the use of any merchandise purchased from Two Brothers Racing. Any merchandise returned to Two Brothers Racing must be sent at the customer's expense with the proof of purchase along with the return authorization number. Two Brothers Racing reserves the right to determine whether the terms of warranty, set out above, have been properly followed. In the event that the terms are not followed, this warranty is void. Two Brothers Racing is the sole arbiter of abuse, misuse, installation errors and modifications. Should any of these be found, this warranty is void. The duration of any and all implied warranties are limited to the duration of the express warrant. All incidental or consequential damages are hereby excluded. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
